



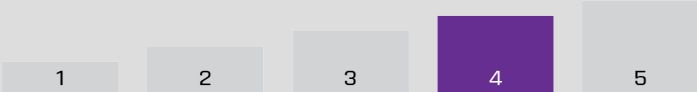

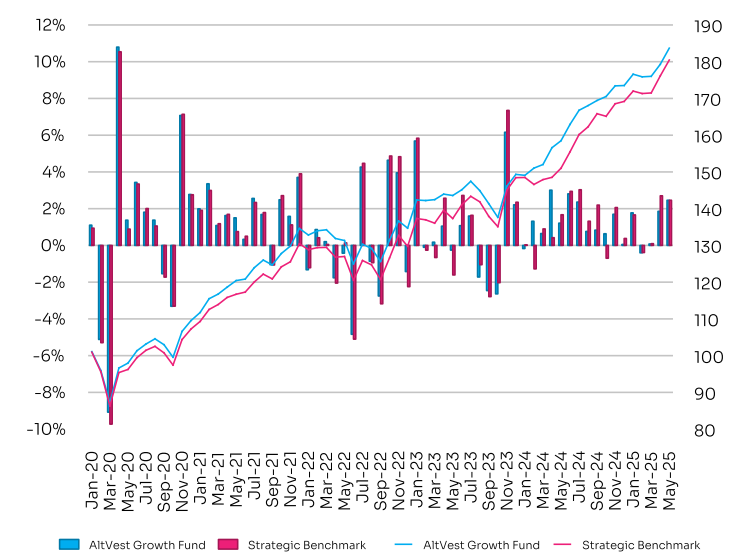
FUND DESCRIPTION

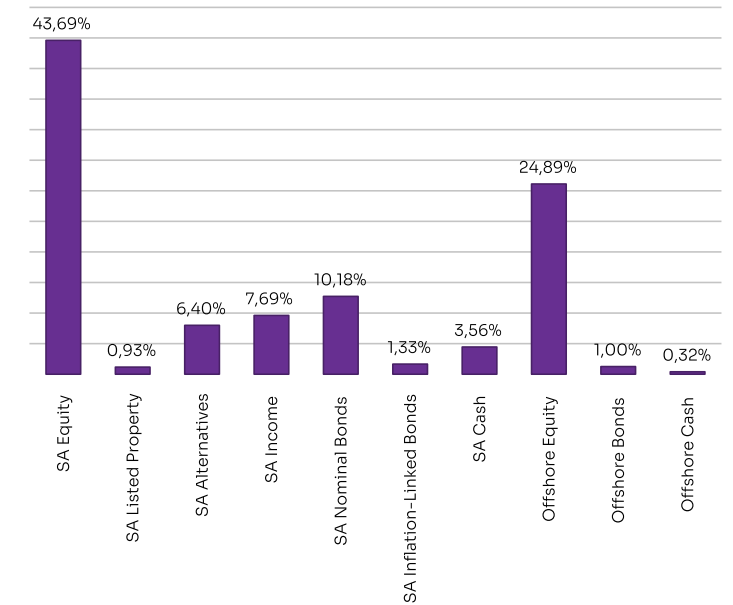
